



# Tuition fees and examination fees 2023-2024

*The tuition fees will be adjusted if changing legislation requires this.*

## STATUTORY TUITION FEES FOR FUNDED STUDY PROGRAMMES

### Reduced statutory tuition fees

Students who join a Bachelor's degree or associate degree study programme will be eligible for the reduced statutory tuition fees (if they meet the requirements for statutory tuition fees).

The reduced statutory tuition fees only apply for the first twelve uninterrupted months of the enrolment as a student. Students can only apply for the reduced statutory tuition fees for two twelve-month periods on an uninterrupted enrolment as a student if they are enrolled in the teacher training programme (the Educational exemption category).

The reduced statutory tuition fees are 50% of the normal statutory tuition fees and amount to €1,157.- for a full-time study programme and €1,064,- for a part-time study programme.

The Hotel Management programme is an exception for which reduced statutory tuition fees of €2,508.- apply. This is in connection with the special distinction 'small-scale, intensive education', as awarded by the Accreditation Organisation of the Netherlands and Flanders (NVAO).

### Full-time study programmes

The statutory tuition fees for a student on a funded full-time study programme amount to €2,314.-, with the exception of the full-time study programme:

a. Hotel Management, which amount to €3,665.-.

*The 'Wet kwaliteit in verscheidenheid' (Act on quality in diversity) allows study programmes that are deemed 'excellent' in the opinion of the Accreditation Organization of the Netherlands and Flanders (NVAO) to differentiate tuition fees on the basis of 'small-scale, intensive education'.*

Students who have enrolled in the 2013-2014 academic year or earlier retain the right to statutory tuition fees.

### Part-time study programmes

The statutory tuition fees for a student on a funded part-time study programme amount to €2,128.- in 2023-2024.

The statutory tuition fees for part-time programmes are increased in 2021-22. A *transition scheme* applies for current students. Current students joined in 2020-2021 or earlier and have not interrupted their studies. The transitional arrangement is not applicable if you switch your study programme (bachelor's degree-master's degree etc./). The transition rate is €1,789.- for 2023-2024. The transition scheme has a maximum duration of five years. If you fall under the transition scheme and have to deregister as a student for more than one academic year due to illness, you can submit a request to the Director of the school to be eligible to pay the transition rate again. The transition scheme lapses from 2026-2027, and all part-time students will pay the applicable part-time rate from that moment on.

### Dual study programmes

The statutory tuition fees for a student on a funded dual study programme amount to €2,314.- in 2023-2024.

## INSTITUTIONAL TUITION FEES FOR FUNDED STUDY PROGRAMMES

If a student does not meet the requirements as laid down in Article 6.1, paragraphs 1 and 2 of Chapter 6 of the [Regulations on Enrolment and Tuition Fees](#), then he or she must pay institutional tuition fees.

The institutional tuition fees for students in funded Bachelor's and Master's programmes depends on the classification of the study programme in the rate groups that are used for government funding. The rates for the 2023-2024 academic year are as follows:

Low	€8,750
High	€10,550
Top	€11,950

The classification of the study programmes in the rate groups is listed in the table on the following page.

### Transition scheme

A *transition scheme* applies for current students. Current students joined in 2018-2019 or earlier and have not interrupted their studies. The transitional arrangement is not applicable if you switch your study programme (bachelor's degree-master's degree etc.). The transition rates are based on the institutional tuition fees for the 2019-2020 academic year, indexed in accordance with the statutory tuition fees and rounded to €50 increments. The transition rate is €8,500 for 2023-2024. The transition scheme has a maximum duration of 5 years and runs until 2023-2024. From 2024-2025, all students will pay the applicable institutional tuition fees. If you fall under the transition scheme and have to deregister as a student for more than one academic year due to illness, you can submit a request to the Director of the school to be eligible to pay the transition rate again.

Exceptions to the transition scheme are:

a. Hotel Management

For students joining in 2018-2019 or earlier, the rate is €9,800.

The transition scheme runs until 2023-2024.

*The 'Wet kwaliteit in verscheidenheid' (Act on quality in diversity) allows study programmes that are deemed 'excellent' in the opinion of the Accreditation Organization of the Netherlands and Flanders (NVAO) to differentiate tuition fees on the basis of 'small-scale, intensive education'.*

b. Midwifery

For students joining in 2018-2019 or earlier, the rate is €10,150.

The transition scheme runs until 2023-2024.

*As the study programme in Midwifery requires significant funding, it is subject to the high institutional tuition fees.*

c. Academy of Music

For students joining in 2020-2021 or earlier, the rate is €8,750.

The transition scheme runs until 2025-2026.

### Students with Ukrainian nationality

Students from Ukraine with Ukrainian passports, who were enrolled in the 2022-2023 academic year and paid tuition fees at Zuyd University of Applied Sciences or another Dutch higher education institution, are eligible for a reduced institutional fee equal to the statutory tuition fee for 2023-2024. This reduction in the institutional fee for academic year 2023-2024 also applies to Prebachelor participants from Ukraine with a Ukrainian passport who were enrolled in Zuyd's Prebachelor in academic year 2022-2023.

## INSTITUTIONAL TUITION FEES FOR NON-FUNDED STUDY PROGRAMMES

### Full-time study programmes

The institutional tuition fees for a student on a non-funded full-time study programme amount to:

a. €11,1000 for the Master FREM (Master of Facility and Real Estate Management).

*The Master FREM is subject to 'all-in' tuition fees that also cover the fees payable to the University of Greenwich.*

1. The final thesis is the final stage of the one-year programme. If the submitted final thesis is given a non-passing mark, it can be corrected within two months and resubmitted without extra tuition fees being owed. If the resubmitted final thesis is given another non-passing mark, a third and fourth opportunity can be given to hand in either a new final thesis or to hand in another corrected version of the original final thesis. In both cases for these extra opportunities, €2,575 in extra tuition fees is owed.
2. The Master FREM student can compete for one of the ten available Master FREM scholarships. Everyone who has been accepted for the Master FREM receives an e-mail from the study programme containing information and the description of the procedure how to apply for the scholarship Master FREM 2023-2024. The ten best candidates will be awarded with the scholarship of €1,500 discount on their tuition fee.
3. For the non-funded Master FREM programme, there is no full or partial refund of tuition fees if students deregister after 1 October. Students leaving the programme between 1 September and 1 October will pay €2,500 to cover the remittance to the University of Greenwich and administrative charges. Students will be refunded the remainder of the tuition fees already paid.
4. Students who have already been enrolled in the FREM master's programme for two academic years and then wish to enrol for a third or subsequent academic year will be charged a fee of €1,500 per academic year.

b. €9,950 for the Master of Arts in Fine Art and Design.

## Part-time study programmes

The institutional tuition fees for a student on a non-funded part-time study programme amount to:

- a. €25,751 for Master of Personal Leadership in Innovation and Change.  
*Due to the modular structure of the study programme, a student will follow most of the programme by enrolling as a participant in a course. A person wishing to follow the Master class in Masterpiece must enrol as a student in order to be registered in 'BRON-HO' (the Dutch database for higher education) as a student. A person wishing to be enrolled as a student must pay institutional tuition fees amounting to €1,071,-. If a student has already paid the institutional tuition fees amounting to €25,751 (for the entire study programme), he or she will receive a discount on the payable tuition fees. Zuyd Alumni and staff members will receive a 10% discount. The structure of the costs is included in the table below.*

- b. €7,350 for the Master FREM (Master of Facility and Real Estate Management).  
 €7,150 for students who have already started the part-time FREM programme in 2022-2023.  
*The Master FREM is subject to 'all-in' tuition fees that also cover the fees payable to the University of:*
- The final thesis is the final stage of the two-year programme. If the submitted final thesis is given a non-passing mark, it can be corrected within two months and resubmitted without extra tuition fees being owed. If the resubmitted final thesis is given another non-passing mark, a third and fourth opportunity can be given to hand in either a new final thesis or to hand in another corrected version of the original final thesis. In both cases for these extra opportunities, €2,575 in extra tuition fees is owed.
  - The Master FREM student can compete for one of the ten available Master FREM scholarships. Everyone who has been accepted for the Master FREM receives an e-mail from the study programme containing information and the description of the procedure how to apply for the scholarship Master FREM 2023-2024. The ten best candidates will be awarded with the scholarship of €1,500 discount on their tuition fee.
  - For the non-funded Master FREM programme, there is no full or partial refund of tuition fees if students deregister after 1 October. Students leaving the programme between 1 September and 1 October will pay €2,500 to cover the remittance to the University of Greenwich and administrative charges. Students will be refunded the remainder of the tuition fees already paid.
  - Students who have already been enrolled in the FREM master's programme for three academic years and then wish to enrol for a fourth or subsequent academic year will owe a fee of €1,500 per academic year.

## EXAMINATION FEES FOR EXTERNAL STUDENTS

### **Full-time study programmes**

The examination fees for an external student on a full-time study programme amount to €2,314 with the exception of the full-time programme:

- a. Hotel Management, for students who joined as of the academic year 2014-2015, which amount to €3,665.

*The 'Wet kwaliteit in verscheidenheid' (Act on quality in diversity) allows study programmes that are deemed 'excellent' in the opinion of the Accreditation Organization of the Netherlands and Flanders (NVAO) to differentiate tuition fees on the basis of 'small-scale, intensive education'. This applies to the study programme in Hotel Management.*

### **Part-time study programmes**

The examination fees for an external student on a part-time study programme amount to €2,128.

### **Dual study programmes**

The examination fees for an external student on a dual study programme amount to €2,314.
